- As per official recommendations, please wear a mask when outdoors on the property and will be at or closer than six feet to others.
- essential workers, a face mask must be worn. They are wearing masks out of respect for you, please reciprocate accordingly. They will respectfully excuse themselves to keep themselves and their families safe.

- If you are a smoker and you are walking in the courtyard or Glen Hollow Drive, please dispose of your cigarette butts in a proper manner. Be courteous to your neighbors and furry friends.
- Residents and their guests may not smoke or vape on their patios.
- As per Suffolk County law chapter 754, Smoking is prohibited in common areas of multiple-dwelling buildings and within 50 feet of a multipledwelling building. Usage of Ecigarettes and "vapes" is also considered smoking by the law and is subject to the same regulations. Please be sure we all adhere to this law; you must be 50 feet away from the buildings. Failure to observe this law could result in fines of up to \$250, repeat offenders could face up to \$1,000 in fines and/or six months in jail.
